

JUDGMENT CONCLUDED IN ROAD ACCIDENT CASE OF PS DIGLIPUR

On 23/01/15 Crime No. 10/15 U/s 279/338 IPC was registered at PS Diglipur against the accused Ashish Jena S/o Shri. N.K. Jena (18) yrs, R/o Aerial Bay. After completion of trial, in the Hon'ble Court of JMFC, Mayabunder the accused found guilty for the offence U/s 279/337/304(A)IPC r.w.s 3/181/146/196 MV Act 1988 and 4(3)(1)A&N Tax Reg. III of 1940. Accordingly, the accused Ashish Jena has been convicted U/s 255(2) of Cr.PC 1973 in the instant case and sentenced to simple imprisonment for 01 year for the offence U/s 304(A)IPC, also sentenced with fine ₹ 1000/- with 06 months simple imprisonment for the offence U/s 279 IPC and sentenced with fine ₹ 500/- with 06 months simple imprisonment for the offence U/s 337 IPC. Imprisonments U/s 279/337/304(A) of IPC will run concurrently. He was further sentenced to pay fine ₹ 500/- for the offence U/s 3/181 MV Act, also sentenced to pay fine ₹ 500/- for the offence U/s 146/196 MV Act and also sentenced to pay fine of ₹ 100/- U/s 4(3)(1) A&N Tax Reg. III of 1940.

The convict Ashish Jena is also directed to pay the compensation of ₹ 20,000/- only to the defecto complainant namely Smti. Archana Bepari, in default of which the convict have to suffer another simple imprisonment for a period of 30 days in addition to the aforesaid one year simple imprisonment.
