### **POLICE MEDAL FOR MERITORIOUS SERVICE**

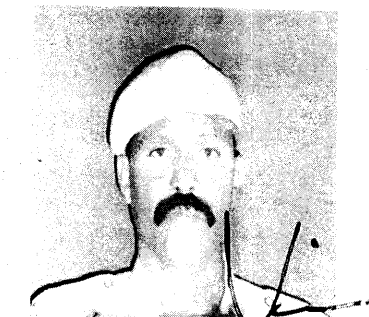
#### **1. Shri. R. Vinod Kumar, Sub Inspector, IRBn:-**


