Resolution of objections raised on questions and answer keys of Written Test of Constable (General Duty) held at JNRM, Port Blair on 01/07/2018.

With reference to our earlier Press Release vide No. DGP/RC/DR/ANP&IRBn/2017/3649 dated 01/07/2018 read with Press Release vide No. DGP/RC/DR/ANP&IRBn/ 2017/3500 dated 23/06/2018, the resolution of objections raised are as follows:-

1. Objection raised on Question No. 19 of SET-B, Question No. 44 of SET-A, Question No. 94 of SET-C, and Question No. 69 of SET-D of Question paper are found correct. The Answer Key for these questions uploaded may read as "B" instead of "C".
2. Objection raised on Question No. 82 of SET-B of Question Paper is overruled and the answer key uploaded is correct.
3. Objection raised on Question No. 74 of SET-D of Question paper and it was found that the question has a discrepancy in its Hindi translation. Consequently, the question is withdrawn from all the Sets of the Question Paper i.e., Question No. 49 of SET-A, Question No. 24 of SET-B, Question No. 99 of SET-C and Question No. 74 of SET-D. Now, the total number of Questions will be 99 and total marks 99.
