NOTIFICATION

Port Blair, dated the 27<sup>th</sup> December, 2019

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Notification No. U-14939/2/83-ANL dated 21<sup>st</sup> February, 1985 and in partial modification of Administration's notification No.132 of 2012 dated 13/06/2012, the Lt. Governor (Administrator), Andaman and Nicobar Islands, hereby makes the following amendment prescribing the method of recruitment of the post of Sub-Inspector (Wireless) (Group B) (Non-Gazetted, Non-Ministerial) in India Reserve Battalion under Andaman and Nicobar Administration namely:-

**1. Short title and commencement: -**

- I. These Rules may be called the Andaman and Nicobar Administration, Andaman & Nicobar Police Department **Group 'B' (Non-Gazetted) posts of Sub-Inspector (Wireless), in India Reserve Battalion**, Recruitment (Amendment) Rules, 2019.
  - II. They shall come into force on the date of its publication in the Official Gazette.
2. (i) the existing entries against Column-4 of Schedule -IV [Sub-Inspector (Wireless)] appended to the Recruitment Rules (herein after called for brevity of the "said Recruitment Rules") shall be substituted as under:-

Level in the Pay Matrix	Level -06 ( Rs.35400-112400)

- (ii) The existing entries in Column 12 of the schedule -IV shall be substituted as under:-

**"Promotion :-**

1. Head Constable (Wireless) of IRBn with 10 years of regular service in the grade in the pay level -4 (Rs. 25500-81100) of the Pay Matrix and should have passed Grade/Level-I Wireless Operator Course conducted by the CPRTI/CPMF.

OR

2. A combined service of 15 years in the grade of Constable (Wireless) and Head Constable (Wireless) of IRBn in the pay level-3 (Rs.21700-69100) and pay level -4 (Rs.25500-81100) of the Pay Matrix of which at least 05 years regular service should be as HC (Wireless) in IRBn in the pay level-4 (Rs.25500-81100) of the Pay Matrix and should have passed Grade/level - I Wireless Operator Course conducted by the CPRTI/CPMF."
