STANDING ORDER NO. 6177

PROCEDURE FOR SELECTION TO THE POST OF POLICE CONSTABLE (DRIVER)  
IN A&N POLICE MOTOR TRANSPORT

This Standing Order is issued in terms of the section 12 of Police Act, 1861.

The Recruitment Rule for the post of Police Constable (Driver) of A&N Police Motor Transport has been notified vide A&N Administration Notification F. No.7-11/2012-Home dated 5<sup>th</sup> March, 2012.

As per Recruitment Rule the post of Police Constable (Driver) in A&N Police Motor Transport will be filled as follow: -

- (i) Direct recruitment
- (ii) 10 % reserved for Police Constable of various units of A&N Police having valid LMV, as per the following arrangement :-

**Note:-**Departmental candidates who apply against the above 10% reserved quota of vacancies are not required to undergo the process of physical measurement and physical endurance tests. In addition, the Departmental candidates can also apply as an open candidate (subject to NOC from the department) in which case they will not be given the above relaxation. They will have to appear for the physical endurance test/written examination/trade test/interview prescribed for other applicants. Separate merit list shall be prepared for departmental candidates against the reserved vacancies.

**1. Eligibility & Procedure:**

- a) Age Limit :**
- 18-25 years (for General)
  - 18-28 years (for OBC)
  - 18-30 years (for ST Category)
- (Relaxable upto 05 years for Govt. Servants in accordance with the instructions/orders issued by the GOI from time to time)

**Note:-** The Crucial date for determining the age limit shall be the closing date for receipt of names/applications from employment Exchange/candidate.

b) **Essential:-**

- a) 10th Standard pass form recognized Board/University
- b) Valid Light Motor/Heavy Motor Vehicle driving License with knowledge of Motor Mechanism
- c) Should possess minimum Physical Standards i.e. -
  - i) Height (General & OBC) - 168 cm
  - ii) Height (ST) - 160 cm
  - iii) Chest (Normal) - 81 cm (77 cm for ST)
  - iv) Chest (Expanded) - 85 cm (81 cm for ST)
  - v) Minimum weight - 50 Kgs (47 for ST)

c) **Desirable:-**

1. Technical qualification in the profession with two years experience in motor mechanism
2. 02 years experience of driving all types of vehicles
3. Ability to drive motorcycle

**Note:** The candidates selected for appointment will have to undergo a training course for a period of 03 months and pass the training.

d) **Physical Endurance Test:**

- i) Race - 1 mile in 7 minutes
- ii) Long Jump - 12 feet (in three chances)
- iii) High Jump - 4 feet (in three chances)

2. **Constitution of Selection Board: -**

A Selection Board consisting of SP as Chairman, two GO's of A&N Police & one nominated member from Transport/BRAIT as members shall be constituted by the Director General of Police.

3. **Written Test (60 marks)**

All those candidates who qualify the Physical Measurements and Endurance Tests shall be put through a written examination of 60 marks. A question paper covering General Knowledge, Simple Arithmetic, and English language will be prepared by an officer nominated by the Chairman. The paper will be set both in Hindi and English and the candidate may answer either in Hindi or English. The answer sheets will be evaluated immediately and the result of the written test will be declared as soon as possible. The minimum qualifying marks in the written test will be 30%. All the candidates who obtain 30% marks in the written test will be called for Trade test.

#### **4. Trade test (25 marks):-**

The candidates who qualify in the written test will be required to qualify in the trade test of 25 marks, which will include: -

I. Parking, Reversing, Garaging	-	07 marks
II. Road Test	-	06 marks
III. Traffic Rules & Signs	-	06 marks
IV. Motor Mechanism & Maintenance	-	06 marks

Only those candidates who obtain 30% or more marks in the trade test will be considered qualified in the trade test.

#### **5. Interview/Personality test (10 marks):-**

The candidates who qualify in the trade test will be called for an interview /personality test. The interview will carry 10 marks. The candidates will be judged on overall personality, aptitude, attitude, general awareness and suitability for the job by Selection Board.

#### **6. Marks for achievement in NCC / Sports:- (Maximum 05 Marks)**

05 marks at the maximum will be awarded for achievement in NCC and/or Sports at the time of tabulation of results as per the scale given below-

i. NCC 'C' Certificate	: 2 marks
ii. NCC 'B' Certificate	: 1 marks
iii. Gold medal at National level in sports	: 3 marks
iv. Silver medal at National level in sports	: 2.5 marks
v. Bronze medal at National level in sports	: 2 marks
vi. Gold medal at State level in sports	: 2 marks
vii. Silver medal at State level in sports	: 1.5 marks
viii. Bronze medal at State level in sports	: 1 marks

The final list of the successful candidates based on aggregate of 100 marks will be finalized soon after conclusion of the interview and the list of selected candidates shall be declared depending on the number of vacancies notified/existing.

#### **7. Medical Standards:**

The successful candidates shall be subjected to a medical examination as given below:-


- i) The minimum distant vision should be 6/6 and 6/9 of two eyes without correction i.e. without wearing glasses. The candidates should not have colour blindness.

- ii) The candidate must not have knock knee, flat foot, varicose vein, squint eyes, bow legs, inability to flex the fingers properly or any other obvious deformities.
- iii) Candidates must be in good mental and physical health and free from any physical defects likely to interfere with the efficient performance of police duties.

Appointment to the post shall be subject to successful completion of medical examination and Police verification report.

For matters not specified in this Standing Order, the decision of the Director General of Police, A & N Islands shall be final.
